5.3 Advice for firefighters

15.2 Chemical Safety Assessment

For this substance a chemical safety assessment has been carried out. According to article 14 of the REACH regulation a chemical safety assessment has been performed. This substance does not meet the criteria for human health or environmental classification, nor does it meet PBT/vPvB criteria. Therefore a use related quantitative risk assessment is not required.

The risk refers to the aspiration hazard (R65/H304). It can be controlled by implementing risk management measures tailored to this specific risk:

worker:

-do not ingest

-keep industrial hygiene

-avoid contaminated working Equipment consumer:

-observe safety instructions with lamp oils and barbeque lighter

-sales of opaque and black container with less than 1 l capacity

-labelling with specific safety statements
